- Judy Heumann is a disability rights activist and author. Her work with governments, non-profits, and disability interest groups since the 1970s has produced significant contributions to the development of human rights legislation and policies benefiting children and adults with disabilities.
- Walter Palmer is a lifelong civil rights organizer, educator, and political activist. He is the founder and director of The Palmer Foundation, and a lecturer at the University of Pennsylvania Graduate School of Social Policy and Practice, where he has taught foundation courses in American racism and institutional racism and social change since 1990.
