- ◇ Civil Rights Law
- ◇ July 26, 1990 – George H.W. Bush
- ◇ ADA Amendments Act of 2008

What is a Disability?

- ◇ A physical or mental impairment that substantially limits one or more major life activities,
- ◇ a person who has a record or history of such an impairment,
- ◇ or a person that is perceived to have a disability.

IMPACT ON OUR JAILS

- ◇ Title II of the Americans with Disabilities ACT
- ◇ Level the field
- ◇ Access to programs, jobs, etc.
- ◇ It's the law

Service Animals – Who is Responsible?

- ◇ What to do when someone is taken into custody with a service animal
- ◇ Local animal shelter/animal control and their role

Booking & Processing

- ◇ Inmate can request during booking/processing phase, or at any time during incarceration.
- ◇ Observe, Listen, Ask
- ◇ “I need _____ because of _____”

Housing

- ◇ Do you have accessible cells?
- ◇ Must comply with the 2010 ADA Standards for Accessible Design if built after 2010.
 - ◇ New alterations to an area, requires that area be brought up to standards.
- ◇ At least 3% of cells for those with accessibility needs such as wheelchairs.
- ◇ At least 2% of general holding and housing cells must be equipped with communications features designed for those that are deaf or hard of hearing.
 - ◇ Minimal standards are 3% and 2% - Doesn't remove responsibility if you have more than that...Plan ahead!

Inmate Housing

- ◇ Common sense placement
- ◇ Staff awareness
- ◇ Cognizant of ADA accommodations during moves

Programs & Jobs

- ◇ When do you have to provide accommodations?
- ◇ Basic requirements are met by the interested inmate
- ◇ Do you have job/programs requirements written?
- ◇ Level the playing field
- ◇ You can't discriminate based on the individual's disability

Visiting

- ◇ ADA applies to both inmates and visitors
- ◇ Service animals for visitors
- ◇ Hearing impairments
- ◇ Visual impairments
- ◇ Accessibility aides
- ◇ Access to visiting area/booths

Direct Threat

A significant risk of substantial harm to the health or safety of employees and others,
which cannot be eliminated or reduced by a reasonable accommodation

- ◇ Magnifying glasses
- ◇ Walkers

The ADA Coordinator

- ◇ **Does your facility have one?**
- ◇ **Does your city, county or state?**
- ◇ **Job importance**
 - ◇ **Agency liability**
 - ◇ **Ensures inmates and staff ADA accommodations are met**
 - ◇ **Works with the city, county or state ADA Coordinator**
 - ◇ **Documentation**
 - ◇ **Regular meetings with those who have accommodations**
 - ◇ **Maintains devices**
 - ◇ **Trains staff members**
